REF-Funded District Positions

Program Spotlights

The REF community funds nearly a quarter of the district's total budget, supporting core programs that make a school a school.

Enrichment Teachers

Credentialed teachers provide art, music, dance, drama, and PE instruction at every school site and allow classroom teachers time to collaborate and plan for excellent instruction.

STEM & Makerspace

STEM coordinator, middle school robotics teacher, math coach, and Makerspace tinkerers collaborate to educate students to thrive in math, science, problem solving, engineering, and beyond.

Literacy

Reading intervention and small group teachers provide targeted student instruction. Literacy coaches provide teacher professional development. These supports enable differentiated instruction to maximize literacy progress for all students.

Central Office

Strategic Projects Coordinator, District Redesign Consultant, and other REF-funded supports were key in helping the district implement the visionary strategic plan and right size staff to best support school sites.

Specialized Middle School Initiatives

REF funding allowed for an additional vice principal, social worker, athletics staff, family outreach and operations coordinators, and other personnel. Overnight field trips to Outdoor Education Camp, Yosemite and Washington DC, after-school sports, and family events create a positive, safe, and engaged onsite culture.

Staff Support

Professional Development

Professional learning was provided for classroom teachers, as well as district and site administrators. Topics included how to give meaning feedback, best practices around dyslexia, and anti-racist teaching strategies.

Pandemic Response

REF supported the district to bring on a Strategic Pandemic Response Consultant who organized vaccine clinics and onsite testing, hired staff to manage the Omicron surge, and ensured in-person learning continued while keeping kids, families and staff safe.

Staff Appreciation

Catered lunches, regular coffee carts, and other appreciations remind teachers and staff our community believes in and supports them. It's been a tough few years for educators; these supports spread love.

Program Spotlights

Holistic programming supports learning and engagement. Students and staff report positive impact.



Robotics

Ravenswood STEM curriculum includes a focus on engineering and robotics programming. Ms. Collier led an inspiring program and the Cesar Chavez Ravenswood Middle School robotics teams hit it out of the park.

- 36 students participated
- 16 teams qualified for VEX Robotics state competitions
- 11 students advanced to world championships

Middle School Athletics

For much of Ravenswood's history there was no organized athletics programming. Now, the district is facilitating robust athletic programming with future expansion plans.

- 97 students participated
- 9 teams competed
- 2 girls basketball players named All Stars
- Co-ed tennis and 6th and 7th basketball made the playoffs
- Hosted a 500 participant cross country meet

UnboundEd Standards Institute

Twenty-five teachers traveled to attend the UnboundEd Standards Institute and spend a week immersed in learning about standards-aligned, anti-racist teaching in service of improving instruction for every child. These teacher leaders are sharing their learnings with their colleagues to implement next steps together.

With REF support, district and union leadership collaborated to create an exciting new evaluation and compensation model designed to retain, recruit, and reward excellent teachers in every classroom.

Ravensed Talent Initiative (RTI)

High quality teaching is the most important schoolbased factor affecting student achievement, yet prior to RTI implementation:

~30%

Ravenswood teachers' salaries were lower compared to neighboring districts' teacher salaries

~40%

Ravenswood teachers left within the first five years

New Contract

Provides equitable compensation for Ravenswood teachers, leaders, and staff:

- A 10% initial raise dramatically reduces the gap with neighboring districts
- Starting salary boosted by 15% and maximum salary by 40%
- Effective teachers have the opportunity for accelerated progress on the salary scale based on the new annual, multi-pronged evaluation

\$12.3 of \$15.4M raised to date

New Evaluation Approach

Focuses on meaningful feedback to promote a culture of growth and embracing change:

- All teachers are reviewed annually: multiple informal observations replace a single formal observation
- Evaluation expanded to include Goal Setting, Self Reflection, and Artifacts of Practice
- Teacher professional growth is supported by coaching and learning opportunities

New Financial Model

A creative public-private funding partnership between REF and the district accelerates the timeline of impact to Ravenswood students. REF is committed to providing up to \$3 million annual contribution for up to 5 years until the district can self-sustain the ongoing costs. "The creativity of REF is they're working with us in service of of our students and our community to give our kids what they deserve; we're thinking this is just the tip of the iceberg."
